CITY COMMISSION EMERGENCY MEETING MINUTES June 16, 2008

An **EMERGENCY MEETING** of the Winter Garden City Commission was called to order by Mayor Rees at 7:00 a.m. at City Hall Commission Chambers, 251 West Plant Street, Winter Garden, Florida.

Mayor Rees stated that a quorum has been met.

1. DETERMINATION, BY AFFIRMATIVE VOTE OF AT LEAST THREE (3) MEMBERS OF THE CITY COMMISSION THAT AN EMERGENCY SITUATION INVOLVING HEALTH, SAFETY, OR PUBLIC WELFARE WARRANTING COMMISSION ACTION EXISTS. (Charter Section 18)

Motion by Commissioner Buchanan that an emergency situation involving health, safety, or public welfare warranting Commission action exists. Seconded by Commissioner Jowers and carried unanimously 4-0.

2. **FIRST READING OF ORDINANCE 08-37:** AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF WINTER GARDEN, FLORIDA, AMENDING OF THE CODE OF ORDINANCES OF THE CITY OF WINTER GARDEN CHAPTER 118 TO CREATE ARTICLE XII, SECTIONS 1610-1612; ESTABLISHING THE DOG FRIENDLY DINING PROGRAM; ESTABLISHING PERMIT REQUIRED; SUBMITTALS, ESTABLISHING GENERAL REGULATIONS; COOPERATION; ENFORCEMENT; PROVIDING FOR CODIFICATION; PROVIDING FOR CONTROL; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE

City Manager Bollhoefer read Ordinance 08-37 by title only. Mr. Bollhoefer explained that this ordinance is required to be adopted in order to allow dogs in the City to be in outdoor eating areas. The elements in this ordinance are required by Orange County.

Commissioner Boulter clarified for the record that this ordinance is not for animals to go inside the eating establishments.

Motion by Commissioner Jowers to approve Ordinance 08-37 with the second reading and public hearing being scheduled for June 26, 2008. Seconded by Commissioner Boulter and carried unanimously 4-0.
