RENTAL POLICIES:

- Alcoholic beverages are not permitted in any City park.
- Pets must be on a leash or caged at all times. Leashes may not be longer than eight-feet.
- Additional restroom facilities or law enforcement presence may be required if the Parks & Recreation Director deems necessary. The renter is responsible for any additional fees.
- Cancellation/Refund requests must be made in writing at least fourteen (14) days in advance
- In order to receive a complete refund, one scheduled date change will be permitted.
- Parking of motorized vehicles at pavilions and buildings is prohibited except for temporary unloading/loading purposes.
- Excessive noise which disturbs other park patrons or surrounding residents is prohibited. The use of amplified speakers or sound is not permitted in any City park.

- Preparations to end the event must begin one (1) hour before park closing time.
- Please return pavilion to the condition in which it was found. Failure to clean the pavilion will result in a forfeiture of the \$75.00 damage fee.
- Tents, canopies, DJ's, bands, shade structures, and hammocks are prohibited.
- Moonwalks, bounce houses, and waterslides are not permitted in any City of Winter Garden park and/or pavilion area.



Veterans Memorial Park
420 S. Park Avenue

- No signs shall be posted on park property. Please notify guests in advance as to the location of the pavilion rental and the content of these rules.
- Decorations are not to be taped, stapled or nailed to any pavilion or park structures. Any decoration tied to pavilion or structures must be removed at the end of the rental.
- Please do not remove, feed or harass wildlife. Collection of plants or firewood is prohibited.
- All parking areas are general in nature and rental does not secure specific allotment.
- Proper supervision of guests under 18 years of age is required and the responsibility of the renter.

- The Damage Fee may be retained if use of the pavilion exceeds the contracted details or requires specific attention for repair or to clean the pavilion.
- The renter accepts sole responsibility for the actions and care of all guests to the pavilion during the scheduled rental.
- Rental agreements and payment must be made NO LATER than 48 hours in advance at the Jessie Brock Community Center, 310 North Dillard Street, Winter Garden, FL 34787 during regular office hours.
